

# HONOR THE SERVICE... REMEMBER THE SACRIFICE

### **A VITAL RESPONSE**

Retired **Sgt. Bradley Thomas** spent 7½ years in the Army. After receiving his infantry training at Fort Benning, Georgia, Bradley was assigned to the 27th Infantry Regiment "Wolfhounds", 2nd Stryker Brigade Combat Team. Just a month after Bradley's unit was deployed to Iraq in December of 2007, his armored vehicle was hit by an IED (Improvised Explosive Device). He sustained major injuries with the most serious being a traumatic brain injury. After many months of recovery and rehabilitation overseas, Bradley's condition improved enough for him to return home but he was changed forever.

Bradley is now in a minimally conscious state. He is nonverbal and requires 24 hour around-the- clock care. His parents have had to make the difficult adjustment of becoming their son's primary caregivers in their home. This responsibility carries the weight of many challenges, most importantly the concern of having reliable working equipment to accurately monitor Bradley's vitals. The Vital Sign Monitor they were using was aging and a new machine was not available through the VA. With nowhere else to turn, they contacted SALUTE, INC. Through faithful donors like you, the necessary funds were raised at SALUTE, INC. events, and we were able to purchase a new \$6,000 Vital Sign Monitor for the Thomas family. This essential piece of equipment is giving Bradley and his parents the security and RELIEF they need to continue to give their son the best care possible for many years to come.

#### REHABILITATE

Chief Warrant Officer, Stephen is a husband, father of 4 and served several tours in the Middle East as a Blackhawk pilot. During his last deployment, he was seriously injured in a helicopter accident and lost the use of his legs. SALUTE, INC. provided the much needed **rehabilitation equipment** to give him greater independence to navigate in his life.

#### REPAIR

Staff Sergeant Claudio's **furnace** went out while he was away in a mental health treatment facility for PTS. SALUTE, INC. covered the repair, making his family's circumstances more manageable.

#### REVIVE

Navy Staff Sergeant Nelson returned home from his deployment with a TBI. Living only one mile from the beach and having a heart for the ocean, he longed for a way to get back into the water but his injuries prevented it. SALUTE, INC. purchased a **water wheel chair** which now helps this Seaman continue to enjoy the pastime he loves.

#### RECOVER

Army Staff Sergeant John, had been receiving disability pay, however his government benefits account was hacked and his monthly pay was not



received. In the midst of this discrepancy, John had been attending a mental health program to assist with his PTS symptoms. SALUTE, INC. provided **mortgage and car payments** for a month – bridging this financial crunch for his family of six until his appropriate pay was resumed.

"There is no better feeling to have than being secure knowing the home is taken care of...my family was able to be worry free of this financial hardship."

#### RELIEVE

Airforce Major Gloria struggled with mobility in the morning due to her combat related injuries. SALUTE, INC. purchased an **adjustable bed** which would help diminish these complications. *"Thank you SO much for helping me finally get the amazing bed that I have needed for years. No more crashing and burning in the morning for this wounded veteran."* 

Army veteran Michael, was shot in the face by a sniper in 2008 and had incurred many other war injuries. He was scheduled for yet another surgery but could not cover the cost of the hotel for his wife to be near him. SALUTE, INC. paid for the **extended hotel stay** so Michael could have the support he needed.







Returning home, he faced many of the difficulties veterans often encounter, and found himself in need of mental health treatment. He was able to find treatment at a veterans' program, but was still under stress due to mounting bills resulting from his young son's illness. Because of our generous donors, SALUTE assisted the family of four with rent payments until their situation was stabilized, allowing Erik to get the mental health **treatment** he was urgently seeking.
