HONOR THE SERVICE... REMEMBER THE SACRIFICE



ONE SAILOR'S JOURNEY OF DISCOVERY.

"There is still humanity out there." It is a simple but strong statement. Much like the man who made it. Navy Chief Petty Officer Nick shared that thought when talking about his dealings with SALUTE, INC.

"For veterans who are battered, who have been injured, working with SALUTE changes your perception and your outlook on humanity," Nick said. For Nick and his family, that meant a lot during a difficult period in their lives.

Nick's story begins, and hopefully, ends with his commitment to serving in the U.S. Navy. As a young man he tried a number of jobs, made a nice living but "didn't feel good." A native of Texas, he came from a family with members who served in the military and ultimately knew that the military gave him "a chance to do something positive." Today, Nick is waiting for the response from a Medical Review Board to green-light his return to service after a long recovery from a serious injury.

As with many families in the military, Nick, his wife Erica and their young daughter Kiyomi, were frequently on the move. He was stationed in San Diego before changing climates for an assignment in Green Bay. It was while stationed there that Nick was out training on his own, hiking and climbing, when he fell 15 feet, landing on his tailbone and compressing his spine. His injuries were painful but not debilitating. He ultimately had surgery which did not offer the expected relief before doctors recommended injections to



his spine to ease his pain. The second instance damaged nerves rendering him paralyzed. There began a long journey of challenges, fear and uncertainty.

His road to healing led Nick and family to the Shirley Ryan AbilityLab in Chicago. Six arduous months brought hope, and through the work of "an amazing staff", Nick slowly reclaimed use of his legs and began to walk again. Like many of us, the coronavirus pandemic added yet another obstacle to Nick's recovery, but he took the periodic interruptions of his therapy in stride. In fact, because he and his family were so focused on his recovery, it wasn't until later in his journey that they came to realize the broad impact the virus was having on society across the country. As someone who has trained with expeditionary command and other special units, relying on his focus, strength, determination and taking problems on directly is the only way Nick knows to operate and a pandemic would simply be another challenge to overcome.

As with any military member, Nick accepted what came his way during the process, but he found it far more difficult to see the impact his situation had on his wife and daughter. "They were away from home, my wife lost her job and my daughter had to see me bedridden, often incoherent due to medication. I believe what they experienced was worse than what I was going through."

Erica's decision to stay by her husband's side led to loss of her job. The family was on its own to cover the cost of a place for her and Kiyomi to live while Nick was at Shirley Ryan, along with daily necessities like gas, utilities and food. And then, a connection was made with SALUTE.

"SALUTE was there for everything," Nick said without hesitation. "They helped financially but the emotional and spiritual support was even greater. SALUTE offered my wife support at all times."

Nick is quick to name SALUTE volunteers like Dan and Rick, as well as Mary Beth and Will Beiersdorf, noting the frequency of their calls and visits.

He remembers that much of his stay at Shirley Ryan was over Thanksgiving and Christmas, yet the SALUTE volunteers "made my daughter's Christmas."

The gift Nick received was not only the use of his legs but his new view on life. "Having to ask for help is not easy for someone who has trained in the military," Nick said. "Knowing what resources are out there has opened my mind to what I can do to help other veterans." He wants others in the military to know it's OK to ask for help, noting that being on the receiving end "empowers you to help others."

We know that Nick will be there any time a member of the military or their family reaches out; and he knows SALUTE will be right behind him. "SALUTE changes lives, pure and simple."

One thing that won't change is Nick's desire to serve. As he awaits the response from the Review Board regarding his ability to return to the Navy, he is making it a priority to show that he is mentally and physically fit to return to the career he loves. We expect that Nick and his family will land on their feet, and when they do, others will benefit.

To all of you who help SALUTE help families like Nick's, we, and they, say thank you. There's still room for a little humanity out there and it's great to have Nick and family help us share that message.

Prior to COVID-19 being a factor, TEAM SALUTE was well represented by 3 teams of 4 who completed the **Pettit Indoor Marathon Relay in Milwaukee.**



The "Running Without a Finish Line" campaign replaced SALUTE's Annual 5K traditionally run through the hometown streets of Arlington Heights, IL over Memorial Day weekend. The campaign was a huge success. Over \$7000 was donated by many faithful supporters some of whom decided to run the course on their own.

Historically, the Bank of America Chicago Marathon has been SALUTE's biggest fundraiser of the year. However due to the pandemic, the 2020 Chicago Marathon, originally scheduled for Oct. 11th was cancelled. Despite that, many of our 100 team members chose to continue their fundraising efforts and run the marathon or half marathon distance virtually in their own neighborhoods. **Adam Thomas**, a 6-year veteran of TEAM SALUTE really outdid himself. He actually ran two virtual marathons, set a post-injury PR and was our top fundraiser exceeding his individual goal by raising over **\$2800**.
